The Cyprus Digital Nomad Visa Scheme

On October 15th, 2021, the Cyprus government introduced its new strategy to attract businesses, especially for non-European citizens. On March 3rd, 2022, the Cyprus Council of Ministers increased the ceiling of residence permits for digital nomads to 500. This Scheme allows third-country (non-EU) citizens who are freelancers or employees who work remotely using telecommunications and technology. The company that employs them or their clients must have their location set abroad.

Such individuals can apply for a Cyprus Digital Nomad Visa to benefit from this Scheme.

In such case, they will be granted a residence permit with the following characteristics:

- They will be able to stay and work in Cyprus for one year. They will have the possibility to renew their permit stay for another two years.
- They can also bring their family members and get granted a residence permit for as long as the Digital Nomad residence in Cyprus. During their stay in Cyprus, the family members are not allowed to work or perform any economic activity in Cyprus.





To qualify for a Digital Nomad Visa, the interested person shall satisfy, among other things, the below requirements:

- Valid Passport for at least three months after arrival in Cyprus.
- **Proof of Remote Work** with an employment contract or other documents for self-employed
- **Proof of sufficient funds is required.** So, they need to prove that they have enough funds to cover their living expenses for their stay in Cyprus on a fixed monthly income. Adequate funds must be the minimum amount of EUR 3.500.
- The interested person must prove their income by an employment agreement or other relevant proof and a bank account. Please note that if a spouse/partner or children accompany the applicant, the minimum amount will be with an extra 20% (twenty per cent) if there is a spouse/civil partner and an additional 15% (fifteen per cent) for each child.
- **Health Insurance** (General Healthcare System GHS); and
- The candidate needs to have a clean criminal record in the country of their residence and needs to provide the relevant certificate for validation.
- Address of Accommodations rental agreement of proof of sale for where they will stay in Cyprus
